



## Simplified Settlement of Death Claims due to recent Floods in affected areas of Andhra Pradesh and Telangana

For ease of customers we have simplified our Claim documentation requirements (relaxation in usual requirements) to expedite Claim settlement. Only the following documents are required to process the Claim:

- Municipal Death Certificate or Death Certified by any competent Government authority/ list of casualties published by Designated District officials of the State Government/ Central Government/ Armed Forces/ Government Hospitals/ Police Authorities
- Completely filled Death Claim Form
- Claimant ID, residence proof & bank account details to ensure claims are paid to correct beneficiary
- Insurance policy document (if available)
